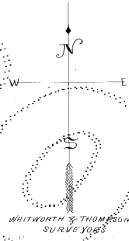


W. T. Denny's

**Explanation**

This D. S. Denny's Park Addition to North Seattle comprises that portion of the D. S. Denny Donation and claim No. 25, situate in Sec. 30 by 25 N. of R. 4 E. in Range D. S. lying between the 3<sup>rd</sup> and 5<sup>th</sup> Additions to North Seattle as heretofore platted by said D. S. Denny. Denny, John, Thomas & Harrison streets are identical in alignment with those streets in the before mentioned 3<sup>rd</sup> and 5<sup>th</sup> Additions to North Seattle. Depot st. is 35 feet wide. Cedar Avenue is an extension of Cedar Avenue in Hill & Denny's Addition to Seattle 16 to 40 ft wide. All other streets are 16 ft wide. Alleys are 16 ft wide. Stone monuments have been set in Harrison st. at its intersection with Box, Birch, 7<sup>th</sup> Oak or streets and in Cedar Avenue at its intersection with the East line of Box st. and with the west line of Birch st. all of which are in record on the plat.

The initial point is the North West corner of Block 16 which is 33 ft South of a 23 East of the Stone Monument set at the intersection of Box & Harrison streets.

**Dedication**

Know all men by these presents that the David S. Denny, & Louise Denny hereby have this day laid out that portion of the D. S. Denny Donation and claim No. 25 here in before described into lots, blocks, streets and alleys in accordance with this D. S. Denny's Park Addition to North Seattle and we do hereby dedicate to the use of the public forever all the streets and alleys platted hereon.
